WHEREAS, Tom and his beloved wife Eileen were married on June 24, 1967 and just celebrated their forty-fifth anniversary; they are the proud and loving parents of five children: Eileen and her husband Michael Ripa, Thomas III and his wife Claire, Madeline and the late Glenn Fitzpatrick, John and his wife Erin, and Rockville Centre Village Trustee Kevin Glynn and have also been blessed with seven grandchildren:
