## Senator Mannion awards \$108,300 to support legal aid organizations in Central New York

SYRACUSE, NY – Senator John W. Mannion today announced awards totaling \$108,300 to support legal aid organizations in Central New York. The funding will help ensure everyone has access to proper legal services regardless of their income level.

The organizations Senator Mannion is assisting provide representation in court, immigration services, help for victims of domestic violence, as well as housing, healthcare, employment and other issues that require legal guidance.

**Senator John W. Mannion (SD-50) said,** “The ability to access the legal system is foundational to our country. I am proud to have secured these funds to support our outstanding legal aid organizations and am incredibly grateful for their work across Central New York.”
