Last week I welcomed members of SAFER (Survivors Advocating for Effective Reform) to my Albany office. The organization was in Albany to discuss legislative initiatives that emphasize the need for enhanced protections for victims of domestic violence.

Earlier this year, I had the opportunity to speak at the Rochester/Monroe County Domestic Violence Consortium's 13th Annual Legislative Breakfast on Domestic Violence. The forum included an overview of the 2011 domestic violence legislation signed into law, as well as proposed legislation for the 2012 Legislative Session. The Rochester/Monroe County Domestic Violence Consortium represents over 50 agencies and organizations that are practitioners in the field of domestic violence.

As this Legislative Session continues, I will again support legislation that stresses zero tolerance for domestic violence.

Clothing and Footwear Sales Tax Change Effective April 1st

New York State will soon provide consumers and businesses a welcome relief at the cash register. Beginning April 1, 2012 clothing and footwear sold for less than \$110 each will be exempt from the New York State's 4% sales tax. The 4% state portion of the sales tax was eliminated in an effort to help consumers save money while bringing in additional revenue to stores throughout the state.
