#### Dear Senator Flanagan:

It is my pleasure to submit the annual report of the Senate Standing Committee on Higher Education for the 2015 legislative session. The committee maintained its commitment to supporting and examining ways to bolster New York's higher education sectors, as well as its oversight of the various professions licensed or seeking licensure by the State Education Department.

The most significant topic discussed by the committee throughout the session was campus sexual assault. After California became the first state to enact an affirmative consent standard for all college campuses, New York followed suit by enacting landmark legislation on campus sexual assault in July. The Senate Majority worked diligently to ensure that all students would be protected and due process rights assured for both the complainant and the accused. This included the publication of a report in October 2014 and multiple roundtables to obtain the input of various stakeholders.

Several other significant higher education bills were enacted throughout the session. Two such bills address the changing landscape of higher education by strengthening its delivery of online education. Chapter 220 authorizes the State Education Department to enter into interstate reciprocity agreements for the delivery of online education on behalf of New York's institutions of higher education. Chapter 437 allows SUNY and CUNY to establish differential tuition rates for non-resident students enrolled in online courses.

Operating and capital funding for SUNY and CUNY are critically important. As such, I sponsored two pieces of legislation that passed both houses of the Legislature. S.281-A would extend the provision requiring a maintenance of effort in funding enacted as part of the 2011 NY-SUNY 2020 legislation to SUNY's three health science centers and direct the State to cover SUNY's and CUNY's collectively bargained costs. The Governor has yet to act on this bill. S.5217 would have provided 5-year capital plans for SUNY and CUNY to ensure that their critical maintenance needs are met. Unfortunately, this bill was vetoed.

The 2015-16 enacted budget increased general fund support for our public four-year colleges and universities and our community colleges. SUNY and CUNY's four-year colleges received an increase of \$34.7 million. Community colleges received a \$100 increase in base operating aid per full-time equivalent (FTE), bringing total base aid to \$2,597. This remains below the 2008-09 level of \$2,675 per FTE. Additionally, the committee continued its efforts to address the college affordability crisis by establishing a new scholarship entitled the New York State Achievement and Investment in Merit Scholarship (NYS-AIMS). Under this scholarship, 5,000

students who demonstrate high academic achievement will receive annual scholarships of \$500 to reduce the level of student loan debt they are expected to incur.

The Governor signed several bills related to the licensed professions. These include an extension and expansion of the collaborative drug therapy management program, the veterinary emergency response and mobility act and a bill to license occupational therapy assistants. As of late November a total of 14 bills reviewed by the committee were signed by the Governor, with a few others awaiting delivery.

I thank the committee for its continued support and commitment throughout the 2015 legislative session. I remain committed to ensuring that New York State higher education is the best in the nation and look forward to working with the committee members and the entire Senate on the various issues affecting higher education in the State.

#### **COMMITTEE JURISDICTION**

The Senate Higher Education Committee is charged with the review and development of legislation addressing postsecondary education for New York State. This includes legislation dealing with the Board of Regents as well as the more than 50 professions licensed by the State Education Department.

The committee's jurisdiction, therefore, covers a broad range of areas including maintaining the quality of New York's public, proprietary and independent colleges and universities, continuing the State's long tradition of providing the nation's most generous student financial aid programs, and providing institutional aid to all sectors of higher education. In addition, the committee plays a key role in program quality, access and opportunities for professional education, encourages academic and private sector cooperation, promotes research, and facilitates elementary and postsecondary partnerships. Furthermore, the committee is deeply involved with the process by which practitioners acquire, demonstrate and maintain professional skills. A major component of the committee's work is to consider change and expansion to the scope of practice of the state's professions, as well as to consider the licensure of newly created professions.

Another important responsibility of the committee is to consider gubernatorial and mayoral nominations to the various boards, task forces and work groups within the higher education community.

#### **2015-2016 ENACTED BUDGET**

The 2015-16 enacted budget honored the commitment made by the NY-SUNY 2020 legislation enacted in 2011 by increasing general fund support to four-year colleges. The State University of New York (SUNY) and City University of New York (CUNY) received \$34.7 million in additional general fund support. Most of the additional funding (\$30 million) will be allocated on the basis of performance improvement plans submitted by the state-operated institutions and senior colleges to the Boards of Trustees. Furthermore, the budget recognizes additional tuition revenues of \$155 million for SUNY and \$60.8 million for CUNY.

Community colleges received an increase in state operating aid for the fifth consecutive year. The increase of \$100 in base aid per full-time equivalent (FTE) brought base aid to \$2,597 per FTE. This remains below the 2008-2009 level of \$2,675. The budget also included language to create regional community college councils to align the operations of community colleges outside of New York City. Additionally, the budget provided \$4 million to support remediation programs at the community colleges, specifically the Accelerated Study in Associates Program (ASAP) at CUNY and Graduation, Achievement and Placement (GAP) program at SUNY. Lastly, funding for childcare centers was increased above prior year levels for the first time in several years, bringing total community college childcare funding to \$3.8 million.

The budget included new funding for a number of other higher education initiatives as well. The most significant of these was the creation of the New York State Achievement and Investment in Merit Scholarship (NYS-AIMS). This scholarship was created to preemptively reduce student debt and will be awarded to 5,000 students who demonstrate strong academic achievement. The budget included \$7.5 million to support this program over two years. Another new initiative was the inclusion of \$1.75 million to support the development of SUNY and CUNY Career Centers. New funding was also added to support small business development centers at SUNY.

#### Other budget initiatives include:

- \$18.6 million in restored funding to SUNY's three teaching hospitals;
- \$8.4 million in funding above the Executive Budget for opportunity programs administered by the State Education Department, which includes the creation of a Foster Youth College Success initiative;
- The creation of the \$5 million Get on Your Feet Loan Forgiveness program;
- \$980,000 to preserve access to the Tuition Assistance Program (TAP) for disabled students taking fewer than the typical number of credits for full-time study;
- \$300,000 to expand the social worker loan forgiveness (\$250K) and young farmer loan forgiveness programs;
- Language promoting the development of career pathways that directs the community college boards of trustees to consult with Boards of Cooperative Education Services (BOCES) on the identification of community college vocational programs to which students would be exposed beginning in the 7<sup>th</sup> grade;
- Language directing SUNY and CUNY to develop a plan for the establishment of an experiential learning requirement; and
- Language to standardize financial aid award letters used by New York State colleges.

#### CAMPUS SEXUAL ASSAULT LEGISLATION

A major highlight of the 2015 legislative session was the enactment of landmark legislation on the topic of campus sexual assault. After more than a year of roundtables, meetings, and the publication of a report by Chairman LaValle in October 2014, the Senate, Assembly, and Governor negotiated an agreement to enact legislation that will apply to all colleges in New York State. Prior to that agreement, the State University of New York (SUNY) and City University of New York (CUNY) adopted different policies for each of their university systems. Additionally, many private colleges had their own policies and procedures for the prevention and handling of allegations of campus sexual assault. There was no uniform statewide policy.

The Governor's 2015-16 Executive Budget included legislation to create a uniform statewide policy for the prevention of and response to campus sexual assault. This legislation codified and sought to apply SUNY's policies to all college campuses in New York State. The Senate included this legislation in its one house budget and the Assembly did not include the legislation. Negotiations during the budget process failed to produce legislation that would be included in the enacted budget.

Discussions on campus sexual assault legislation resumed after the enactment of the budget. Several areas were discussed throughout negotiations, including:

- the definition of affirmative consent;
- the use of appropriate terminology to describe the alleged victim and the accused;
- due process protections for both the complainant and respondent; and
- the education of incoming students about sexual assault.

The enacted legislation included several key changes to the Governor's budget language.

- Affirmative consent: Affirmative consent is defined as a "knowing, voluntary and mutual decision among all participants to engage in sexual activity. Consent can be given by words or actions, as long as those words or actions create clear permission regarding willingness to engage in the sexual activity." The original definition of affirmative consent suggested that consent had to be verbal.
- Terminology to refer to the alleged victim and the assailant: The terms "accused," "respondent," and "reporting individual" were used to refer to the assailant and victim, and are expected to be the terms used in the course of any proceeding held to adjudicate matters of sexual assault on campus.
- *Due process:* Language was inserted to clarify that the accused or respondent has a right to a presumption of "not responsible" until a finding of responsibility has been made in the course of a college adjudicatory proceeding.
- *Incoming Student Education*: All colleges are expected to develop an ongoing educational campaign for incoming and returning students, which may include education on the dangers of underage and binge drinking.

Lastly, reporting provisions were also included in the enacted legislation, whereby the State Education Department would collect and publish data submitted by colleges on sexual assault.

#### **Economic Development and Higher Education**

#### **BUDGET FUNDING**

The Transformative Investment Program (TIP) appropriated \$400 million in funding, which may be used, in part, to support the creation of a "biotech corridor" on Long Island. The biotech corridor would involve collaboration among Long Island's higher education and research institutions, including Stony Brook, Cold Spring Harbor, Brookhaven National Laboratory, Hofstra University and North Shore Long Island Jewish Health System. This investment in intellectual infrastructure of up to \$175 million would support the development of a new innovation economy.

The enacted budget also provided funding for a fifth round of SUNY 2020 Challenge Grants, with \$55 million apiece in capital funding allocated for SUNY and CUNY. Other capital initiatives include \$25 million to support the development of a school of pharmacy at Binghamton University and \$19 million for the College of Veterinary Medicine at Cornell University. In terms of operating funding, the budget added \$1.3 million to the Executive Budget amount of \$8.7 million for a total of \$10 million for the Centers of Excellence (COE) program. The 10 centers each received \$1 million. The Centers for Advanced Technology (CAT) program received \$13.8 million.

#### SUNY & CUNY CAPITAL PLANS

The budget did not include a five-year capital plan to meet the infrastructure needs of the State's public higher education institutions, however a significant piece of legislation (S.5217/A.7388) passed the Senate and Assembly. The bill would bolster critical maintenance funding for SUNY's and CUNY's academic infrastructure. Specifically, it would direct the Governor to produce five-year capital plans that address critical maintenance needs at the colleges, beginning with the fiscal year commencing on April 1, 2016. The last robust five-year capital plan was enacted as part of the State Fiscal Year 2008-2009 budget.

#### START-UP New York

Enacted in 2013, the START-UP New York program has come under scrutiny in the past year. The program is designed to foster entrepreneurialism and job growth by leveraging New York's public and private colleges. However, the use of State dollars to advertise the program, which is being overseen the Empire State Development Corporation, has been criticized. Furthermore, job creation under the program has come to be seen by its critics as lagging.

As of mid-September, START-UP New York secured commitments from 143 companies to create 3,841 jobs and invest more than \$184 million over the next five years across the State. Twenty-nine different colleges and universities are sponsoring companies. As the program moves forward, greater emphasis should be placed on oversight of the use of State dollars to support its expansion and efforts to link the program to experiential learning and career development for New York's college graduates.

#### THE PROFESSIONS

The Higher Education Committee is responsible for the review and analysis of legislation affecting various licensed professions within the State. In recent years, the final state budget has included significant professions policy. This year marked a deviation from that recent trend. However, the committee reviewed, and the Legislature ultimately passed several bills related to the professions.

#### Collaborative Drug Therapy Management

Originally authorized in 2011, the Collaborative Drug Therapy Management (CDTM) program was extended and expanded in 2015. The pilot program authorized pharmacists to review, evaluate and manage drug therapy for patients being treated by a physician for specific disease states. The original program restricted CDTM to teaching hospitals. This year's legislation continues the existing program for an additional three years and expands it to additional settings, including general hospitals and nursing homes staffed with a licensed pharmacist.

#### Pharmacist Immunizations

Legislation to extend for three years the authorization for pharmacists to administer certain immunizations passed both houses of the Legislature. The legislation allows pharmacists to administer vaccines for acute herpes zoster, meningococcal, tetanus, diphtheria or pertussis pursuant to a patient or non-patient specific order. It included new language to facilitate greater levels of interaction between pharmacists and primary care practitioners, as well as patient privacy and cost information.

#### Veterinary Emergency Response and Mobility Act

This bill would authorize the use of veterinarians and veterinary technicians licensed in other states for emergencies arising from natural disasters or animal cruelty investigations. The State Education Department (SED) would have disciplinary authority over these professionals, who would be vetted by law enforcement authorities to determine if they possess the necessary skills, training and experience.

#### Exemptions from Psychology Licensure

Two exemptions from psychology licensure passed the Legislature. The first would allow a technician with a bachelor's degree in psychology or a related field to work under the supervision of a licensed psychologist for the purpose of scoring and administering neuropsychological examinations. The technician would be prohibited from interpreting or evaluating observations and would be required to undergo a minimum of 80 hours of training.

The second exemption would ensure that certified school psychologists are allowed to conduct multidisciplinary evaluations for, and provide services to children served by pre-school special education programs and early intervention programs. The exemption expires on June 30, 2016.

#### Occupational Therapy Assistants

This bill would provide for the licensure of occupational therapy assistants (OTAs) and expand the board of occupational therapy to include an OTA. An OTA would be required to complete a two-year program and 16 weeks of clinical experience to qualify for licensure.

#### Out-of-State Clinical Laboratory Practitioners

Under this legislation, the Department of Health (DOH) would be required to establish qualifications for out-of-state clinical lab practitioners licensed in New York by July 1, 2016, after consultation with SED. DOH would also require attestations from out-of-state clinical lab directors that these practitioners meet the qualifications established.

#### Vision Impairment Specialists

After several years of introduction and multiple amendments, legislation to license vision impairment specialists passed both houses of the Legislature. The bill would license low vision specialists, orientation and mobility specialists and vision rehabilitation specialists who obtain a baccalaureate degree or higher from a program with an approved curriculum, and meet examination and experience requirements.

#### LOOKING AHEAD: COLLEGE COSTS AND STUDENT DEBT

College costs and student debt continue to be major public policy issues, affecting students and families alike. The Project on Student Debt reported that 60 percent of students graduating from four-year colleges in New York incurred student debt, and the average student debt per graduate exceeded \$26,000 for the class of 2013. It has no doubt since climbed.

Although the impact of student debt cuts across the various sectors of higher education, data released by the federal government in September revealed that the run-up in student debt that has occurred in recent years has been driven largely by for-profit institutions, and to a lesser extent, community colleges. Legislation enacted in 2012 strengthened the State Education Department's oversight of the for-profit sector. More work is needed to improve community college outcomes and reduce the impact of student debt on community college students.

Several four-year independent colleges in New York, which have higher "sticker" prices than colleges in other sectors are innovating to address college costs and student debt. Houghton College offers loan repayment assistance to graduates that make less than \$38,000 per year. The Sage Colleges have instituted tuition freezes. Hartwick College and St. John's University are offering three-year bachelor's degree programs. Utica College announced a tuition reset, or reduction of 43 percent, in September.

The State's public four-year colleges have among the lowest tuition rates for its sector in the nation, although these rates have steadily climbed since the enactment of NY-SUNY 2020 in 2011. Five consecutive years of tuition increases have brought in-state public college tuition to more than \$6,300 annually. The State University of New York (SUNY) and City University of New York (CUNY), charges students substantially less in tuition and fees than the national average for four-year public colleges and universities, which the College Board approximates at \$9,139 per full-time undergraduate student. The expiration of NY-SUNY 2020, which authorized annual tuition increases of \$300 at SUNY and CUNY, should be carefully reviewed by the Legislature.

State taxpayer support for higher education, which exceeds \$6.6 billion, is designed, in part, to make college affordable. After multiple years of no nominal increases, and in some cases reductions, the State is once again making additional investments in higher education, and public higher education in particular. Below are initiatives to consider as part of the 2016 legislative cycle that could further curb college costs and reduce the impact of student debt:

- Reimbursement for Educational Achievement and Proficiency (S.484): This legislation would reimburse students for community college tuition costs after they meet specific requirements, including timely graduation.
- **Community College Tuition Cap**: The 2015-16 Senate One House budget included provisions to freeze tuition at community colleges whenever state aid increases by at least three percent. Tuition increases can be capped at two percent whenever state aid increases by at least three percent.
- **NY-AIMS:** As stated earlier in the report, this scholarship awards \$500 to students most likely to incur student debt. The program is currently only funded for two years.

- **TAP Award Increase:** The gap between the maximum TAP award and public college tuition has been in place since the implementation of NY-SUNY 2020's tuition increases. SUNY and CUNY currently mitigate the impact of this gap to the student through a tuition credit.
- **Bundy Aid:** The enacted budget includes \$35.1 million in unrestricted aid to independent colleges awarded on the basis of the number of degrees granted. The program could be modified to reward colleges for graduating students with lower debt levels and overall funding could be increased.
- **Double the Tuition Tax Credit (S.23):** This bill would phase-in over five years an increase in the existing tuition tax credit, which is currently capped at \$400 annually.
- Tax Deduction for Student Loan Interest: Although the federal government offers a tax deduction on student loan interest, the State has no similar deduction. Given the magnitude of student debt, the State could enact legislation to establish a tax deduction for student loan interest paid.
- **Support Online Education:** As costs for traditional "bricks and mortar" higher education continue to climb, more students are seeking affordable options such as online education. Ensuring adequate levels of state funding for initiatives like Open SUNY will help to preserve and expand an increasingly more affordable option for many students.

#### LOOKING AHEAD: THE PROFESSIONS

Two critical exemptions among the licensed professions are slated to expire at the end of June. The first of these involves the agency exemption from licensure for social workers, mental health practitioners and psychologists. The second relates to school psychology.

#### Social Work, Mental Health and Psychology Licensure

In 2002, New York State enacted laws to restrict the practice of psychotherapy and related services to those licensed by the State Education Department (SED). These laws exempted from the licensure requirements individuals employed by programs and services regulated, operated, funded or approved by the Office of Mental Health (OMH), Office of People with Developmental Disabilities (OPWDD), and the Office of Alcohol and Substance Abuse Services (OASAS). Legislation enacted in subsequent years expanded these exemptions to the Office of Children and Family Services (OCFS), Department of Health (DOH), State Office for the Aging (SOFA), and the Department of Corrections and Community Supervision (DOCCS).

At the time of original enactment, the profession of psychology received a permanent exemption from licensure for individuals employed by governmental entities. However, the exemption from licensure for social workers and mental health practitioners was intended to be temporary.

The cost of licensing the unlicensed professionals is a point of concern that culminated in the most recent extension of the exemption. In 2013, the cost of allowing the exemption to expire was estimated at more than \$400 million. Implicit in the fiscal estimate was the assumption that certain paraprofessionals not engaging in activities that fall within the restricted scope of practice of the licensed professionals would need to be licensed. As a result, the Legislature worked diligently to clarify specific activities that may be performed by unlicensed individuals.

The chairs of the higher education committees wrote to the Governor in early October requesting that the exemption not be extended past July 1, 2016. This would do much to reverse the development of a two-tiered system in which many of the patients served by programs and services operated, funded, regulated or approved by the seven aforementioned state agencies receive care from unlicensed practitioners.

#### School Psychology

The Governor signed legislation (Chapter 217) in August to allow certified school psychologists to continue conducting multidisciplinary evaluations for early intervention and preschool-age children suspected of having disabilities. This legislation was a response to the issuance of a SED field advisory that restricted the conduct of evaluations to those licensed or otherwise authorized by SED. The legislation expires on June 30, 2016.

In October, the Chairman sponsored, and staff facilitated a roundtable to discuss the licensure of school psychologists, as outlined in Senate Bill S.4995. Representatives from the State Psychological Association, Neuropsychological Association and State Association for School Psychologists were present. Licensure is one option to address the expiration of chapter 217 in 2016. However, the State Psychological Association and State Association for Neuropsychologists remain opposed to school psychology licensure.

#### **NOMINATIONS**

Pursuant to Title VII of the Senate Rules, the Higher Education Committee is charged with reviewing gubernatorial appointments to the Boards of Trustees of the College of Environmental Science and Forestry, Cornell University, City University of New York, City University Construction Fund, Higher Education Services Corporation, State University of New York and the State University Construction Fund. In addition, the committee reviews nominations by the Mayor of the City of New York to the City University Board of Trustees.

Nominees recommended by the Higher Education Committee are referred to the Senate Finance Committee. The following nominees were recommended and approved in 2015:
