2024 Joint Legislative Budget Hearings: Environmental Conservation February 14, 2022

The Honorable Pete Harckham, Deborah Glick, Liz Krueger, and Helene Weinstein:

From the *Buffalo Zoo* to the *New York Aquarium* and everywhere in between, the Zoos, Botanical Gardens, and Aquaria (ZBGA) line of the Environmental Protection Fund (EPF) directly supports *essential* staff caring for living collections of 97 zoos, botanical gardens, nature centers and aquaria in every corner of NY State. This four-decade success story would not be possible without the leadership and historic, constant support of the NY State Assembly and Senate. Thank you!

For reasons that are not clear or necessary, Governor Hochul's SFY 24/25 Executive Budget cuts the EPF's historic \$400 million funding level by \$25 million, using this dedicated revenue to cover state agency staffing costs. The Governor's proposal reduces many important EPF programs and severely cuts the ZBGA appropriation by 15%, reducing the statewide fund from \$20M down to \$17M. A \$3M cut to ZBGA would result in proportionate cuts to each grant recipient – a reduction too severe for any non-profit organization, even in the best of times.

Like every non-profit, living museums are facing increased operating expenses at an alarming rate. Although every measure is taken to reduce costs and operate efficiently, animals must be fed, botanical collections must be nurtured and the salaries of the staff who accomplish these vital tasks must be funded. Living museums prove themselves a sound investment for NY State funding through the four decades of ZBGA funding. We are economic generators providing good paying jobs, serving as living classrooms that educate over a million schoolchildren annually, and are safe green spaces accessible to all New Yorkers no matter their socioeconomic circumstances.

Living Museums statewide are extremely grateful to the NY Assembly and NY Senate for growing and protecting this program over the last decade, and ask you reject the cuts / offloads to the EPF, and actively work to restore ZBGA program to at least \$20M.

There are three, primary reasons why restoration of ZBGA should be a priority:

1.) <u>Restoring ZBGA maintains employment and fuels economic development:</u>

Living museums provide more than quality environmental education and uniquely beautiful tourist destinations; they are strong economic engines during difficult times. Leveraging ZBGA funding awarded through a competitive grants process, living museums employ at least 14,000 New York State residents and generate hundreds of millions of dollars each year for the state in tourism dollars and economic development.

Institutions like the Buffalo Society of Natural Sciences, the Utica Zoo, and the Wild Center in Tupper Lake are core to stabilizing local economies by providing good-paying jobs and supporting local businesses. Wildlife Conservation Society and the New York Botanical Garden both have a major economic impact on the Bronx and New York City – generating significant amounts of employment, purchasing goods and services, and drawing visitors and visitor spending to the city. This impact benefits not just the private sector, but also generates substantial tax revenues through sales and income tax receipts from employees.

2.) <u>Restoring ZBGA helps outdoor museums remain accessible to the public at a time when families</u> <u>need *safe*, and *economical* outdoor experiences most:</u>

Access to economical, safe green space, particularly in urban areas, is an issue of equity and fairness. Our visitors are often our neighbors, many of whom are not able to travel to one of our magnificent State Parks. As the cost of living increases so does the cost of many family recreational activities. Over 2 million of our visitors enjoy free or reduced-cost access. Our organizations provide an economical option where families not only can enjoy recreation but can strengthen their connection to our living planet and the responsibility we all shoulder to care for it. In staying close to home, many also experience large crowds and the lack of safety enforcement in our municipal park system. In short, botanical gardens and zoos help to meet the demand for *safe and economical outdoor space* at a time when New Yorkers' mental and physical health need the extra boost resulting from time outdoors.

3.) <u>Restoring ZBGA maintains quality environmental literacy programs statewide:</u>

While living museums advance their missions by helping to breed and protect endangered species, addressing the impacts of global climate change, and fighting the spread of invasive species, we are most proud of educating and inspiring over 1 million school children and thousands of public school teachers, literally growing the next generation of conservation stewards. It is not a stretch to say that living museums are the state's heartbeat of ecological literacy. Critical to the goals of the EPF, living museums educate the next generation of conservation stewards and <u>create an informed electorate</u> that values and understands the severe threat to our planet posed by climate change. More, now than ever, living museums are critical in providing rich, conservation-based educational experiences for classrooms and teachers

For all these reasons—and so many more— we implore the Legislature to maintain EPF at \$400 million without agency offloads and restore ZBGA to at least \$20M in the adopted SFY 24/25 budget.
