**<u>QUESTION #1</u>**: Child Welfare Worker scholarship and loan forgiveness program budgets were each only budgeted \$50K, no change since last year. How many applications have you received, and how many awards have been made? Recruitment and retention issue in the field.

**ANSWER #1**: The New York State Child Welfare Worker Loan Forgiveness Program provides student loan forgiveness awards for the purpose of attracting workers to be employed in NYS child welfare agencies. Recipients can receive awards up to \$10,000 per year for up to 5 years, not to exceed the total amount of the recipient's student loan debt.

**<u>QUESTION #2</u>**: Excelsior and ETA awards - \$136M budgeted for Excelsior represents a decrease. Is this based on enrollment decrease? How many students are receiving ETA?

**ANSWER #2:** The \$136M estimated for Excelsior realigns the appropriation with anticipated actual awards for the program. It is not a reflection of an enrollment decrease.

Per the Annual Report Data, ETA is projected to have 2,702 recipients in AY 2022-23 and 2,535 recipients in AY 2023-24. There are fewer schools participating in the ETA Program.

**QUESTION #1:** Provide follow up information on the Nursing Faculty Loan Forgiveness Program.

**ANSWER #1:** The Nursing Faculty Loan Forgiveness Program (NFLF), also known as Patricia K. McGee Loan Forgiveness Program, is a competitive loan forgiveness program. Education law limits funding amounts to the amount appropriated; and is therefore based on availability of funds. NFLF is offered to increase the number of nursing faculty members and adjunct clinical faculty teaching in the field of nursing in NYS. Awards are made annually to licensed registered nurses holding graduate degrees and who have taught in the field of nursing.

The program was initiated in 2005. The program is open to returning students first and then new applicants, depending on funding availability. HESC does not require returning students to re-apply, but the applicant must confirm their eligibility by completing a HESC-issued questionnaire; applicants also must submit a payment document to confirm the loan amount. New students must apply and, if eligible, will receive an award AFTER the returning students' applications are funded.

There have been no new applicants for the McGee Loan Forgiveness Program since AY 2020-21 due to the pause on student loan repayment. This program will open for applications in 2024.
