 A New Direction for Long Island**



Dear Friend,

When I took office on January 1, 2011, I made a commitment to work hard to cut taxes, reduce wasteful spending and help create jobs.

Working together with Governor Cuomo, we're making major progress in achieving these key goals.

To help Long Island small businesses, I worked with a coalition of business and civic leaders to successfully force a repeal of the job-killing MTA Payroll Tax for 80 percent of the employers previously paying the tax, while providing a reduction to thousands of others. We enacted two consecutive on-time budgets and closed a \$13 billion budget deficit without increasing taxes or fees.

Additionally, I supported a \$3.3 billion tax cut package which reduced the middle income tax rate to the lowest level in 58 years. To help Suffolk homeowners and seniors, we also worked together to enact a 2 percent property tax cap that has already helped save local taxpayers \$17 million.

The positive results are starting to show.

According to a report by the US Chamber of Commerce, New York has rose 11 spots in the rankings of states for economic growth, productivity and livability. In addition, Standard and Poor's recently boosted New York's credit outlook to positive, based on two consecutive on-time budgets, deficit reduction and long-term spending reforms.

We've made real progress, but we still have more work to do. As your Senator, I will continue fighting to ensure a stronger, brighter future for our local community, and for all of Long Island.
