## Message from Liz . . .

The Senate will return for a session on September 10<sup>th</sup>, and I have been advocating for passage of ethics reform legislation at that time. I believe that it is critical that the Senate continue to take steps showing we are serious about setting higher standards for all public officials. The Assembly passed ethics reform legislation earlier in the session (A.9032/S.6064) which strengthens ethics oversight and financial disclosure requirements, and establishes a new Legislative Office of Ethics Investigations to ensure allegations of impropriety are appropriately reviewed. Passing this bill would be a good start, but I also think recent events have highlighted the need for more fundamental reforms.

There are three bills that I sponsor that I am pushing to be moved as well; as separate bills or incorporated into chapter amendments for the above bill:

- S.743 which defines permissible uses of campaign contributions to ensure they are used for electoral or governmental purposes only, and not to pay personal expenses;
- S.744 which requires disclosure by lobbyists of any financial or business relationship with a public official, and sets limits on the amount lobbyists can contribute to candidates; and
- S.1733 which denies pension benefits to any elected official convicted of a crime involving the performance of their public duties.

There are many other ideas for reform which other Senators carry and I co-sponsor, and if we can act on some of these measures on September 10<sup>th</sup>, there will be plenty of time for the Assembly to pass them when both houses come back to deal with the other big crisis we face – the deteriorating financial situation in the State. Addressing the budget crisis will be a real challenge given the divisions in the Senate, but it is clear there are going to have to be midyear reductions, perhaps to the tune of 2 billion dollars.

# SPOTLIGHT ON POLICY

### **Telecommunications Taxes**

On August 12<sup>th</sup>, I held a roundtable focused on the creating a more rational and transparent tax structure for the telecommunications industry. Tax policy experts from around the country came to Albany to discuss with my Select Committee on Budget and Tax Reform ways to bring New York State's telecommunications taxes into the 21st century.

Recognizing how New York tax policy has created inequities in the telecommunications industry by failing to keep pace with its rapidly-changing technology and practices. Roundtable participants included tax policy experts representing service providers such as Time Warner Cable, Cablevision, Verizon, AT&T, DISH Network and DirectTV. Also attending the meeting were experts who have worked with the National Conference of State Legislatures and the Council on State Taxation in drafting blueprints for equitable state telecommunications tax methods for the 21st century.

Almost 15 years have passed since New York last gave its telecommunications taxes an overhaul. To usher in that reform it took an appellate court ruling which said a section of the State's Utilities Tax discriminated against interstate and foreign commerce.

Although the 1995 reforms addressed the issues raised by the court ruling, a subsequent New York State Department of Taxation and Finance report noted the "current system results in some taxpayer inequities" and "competitive changes within the industry will exacerbate these inequities." Taxpayers confront these inequities when they shop for telecommunications services and realize that similar voice, video and data services are more heavily taxed primarily because their providers are subject to different articles of New York's Tax Law.

Something seems amiss when Telecom X says the taxes on its services are vastly higher than taxes on similar services offered by Telecom Y.

Another factor contributing to these inequities is the complexity of New York's telecommunications tax system. Highlighting the extent of this complexity, in the State Budget passed earlier this year, the Senate directed the Department of Taxation and Finance, in consultation with the Public Service Commission, to perform a full accounting of the State's telecommunications taxes. The results of this study will be issued in a report by October 1st.

The challenge for New York State is not only to catch up with where we are now, but to also have the foresight to frame tax policy in a way that is conducive to telecommunications in the years to come.
