Hearing: 180	Ear Wax Screening: 120
Peripheral Artery: 200+	Prostate Screening: 89

## National Alzheimer's Awareness Month



November is National Alzheimer's Disease Awareness Month. This month, we remember the loved ones we have lost to Alzheimer's, and we stand with the families, caregivers and medical professionals who improve the lives of those affected by this disease. In New York State, it is estimated that more than 320,000 people aged 65 and older are currently affected by Alzheimer's.

The Alzheimer's Foundation of America (AFA) (<u>http://www.alzfdn.org/</u>) is hosting two initiatives this November aimed at raising awareness of this devastating brain disorder – National Commemorative Candle Lighting (<u>http://www.candlelighting.org/</u>) on November 13, 2011 and National Memory Screening Day (<u>http://www.nationalmemoryscreening.org/</u>) on November 15, 2011.

As part of AFA's National Commemorative Candle Lighting, various Alzheimer's organizations, long-term care facilities and community groups will be lighting "candles of care" November 13<sup>th</sup> to remember people who have passed away or are living with Alzheimer's.

On November 15<sup>th</sup>, healthcare professionals will offer free, confidential memory screenings and information about Alzheimer's during AFA's National Memory Screening Day. Two screenings held in our communities are scheduled at Peace of Christ Parish from 9:00 a.m. to 3:00 p.m. and Kmart Pharmacy's Health and Wellness Center from 9:00 a.m. to 1:00 p.m. Other screenings will be added to the AFA's website as more organizations sign up to participate.

During National Alzheimer's Disease Awareness Month, we stand united in our commitment to improve healthcare for Alzheimer's patients and support the caregivers and families affected by this devastating brain disorder.
