WHEREAS, The SuperPantry offers its clients hundreds of nutrition education classes, workshops, and cooking demonstrations each year, and its urban farms and the Green Teens who maintain them have continued to infuse heart-healthy fruits and vegetables into food deserts and provide gainful employment to local youth; and

WHEREAS, In addition, this remarkable organization offers a variety of social services, including SNAP registration, health insurance enrollment, and tax filing preparation; and

WHEREAS, Today, under the luminous leadership of Dr. Melony Samuels, The Campaign Against Hunger continues to evolve as food insecurity, economic inequality, and health disparities continue to plague our communities; and

WHEREAS, The success of The Campaign Against Hunger is in direct correlation to the efforts of its Board of Directors and staff, whose involvement is, and always has been, characterized by an impressive commitment, an unbridled enthusiasm, and an uncompromising standard of
