WHEREAS, A vibrant individual who remains so full of life, Lucille Sauter is an avid Yankees fan; and

WHEREAS, Lucille Sauter, with her zest for life, has inspired and enhanced the lives of her family and friends; and

WHEREAS, This exceptional centenarian has experienced the incredible joys and sorrows characteristic of and reserved for those with the stamina and courage to savor a full life; and

WHEREAS, Lucille Sauter has enriched the lives of those around her through her joyous and sincere love for others and through the profound charm and wisdom which comes only from a fullness of years; and
