WHEREAS, Charles Joseph Sally of Peekskill, New York, died on Monday, April 24, 2023; and

WHEREAS, The son of Irish immigrants John and Margaret (O'Neill) Sally, Charles Sally, affectionately known as Charlie, was born and raised in the Bronx, New York, alongside his siblings, John "Jackie", Lucille, Ann and Mary; and

WHEREAS, With a steadfast and unwavering commitment to his community, Charles Sally was also a Life member of the Peekskill Elks Club; and

WHEREAS, Charles Sally and the former Mary Morris were united in marriage in 1966 at Assumption Church in Peekskill, New York; the couple enjoyed a long and loving marriage until Mary's passing in 2000; and

WHEREAS, A man of indomitable faith and dedication, Charles Sally was a devoted Catholic; he had the gift of gab and loved to spend time with his friends and family, especially his lifelong childhood friend, the late Fred "Freddy" Beuchert; furthermore, he lived in the home he and his beloved wife shared in Peekskill until his passing; and

WHEREAS, Charles Sally is survived by his godson, Frank Quaranta; and goddaughter, Lisa Cutts; as well as his nieces and nephews, Lisa Greene, James Quaranta, Bob Morris, Diane Mohr, and Karen Cortese; and
