WHEREAS, Serving over 60,000 members, First Source Federal Credit Union currently has branches in New Hartford, South Utica, North Utica, Herkimer, and Rome; they have services such as a Member Care Center, Online and Mobile banking, and access to First Source Interactive ATMs, as well as over 30,000 nationwide surcharge-free ATMs; and

WHEREAS, New this year, First Source Federal Credit Union has launched Video Engagement Technology allowing members to interact with a live First Source Financial Service Representative from any location; in the near future, contactless card payment options for both Business and Consumer credit and debit cards will be offered; and
