WHEREAS, In addition to her latest New York State championship titles, Angelina McKane was named the 2021 and 2022 Section IV Class A Swimming and Diving Championship Outstanding Performer and is a three-time Southern Tier Athletic Conference All Star; and

WHEREAS, Angelina McKane is also an exceptional student, having maintained High Honor Roll status since 2020, and as a member of the National Junior Honor Society; she is a member of her school's Student Council, Youth Activation Committee, and the Future Business Leaders of America; and

WHEREAS, Angelina McKane also enjoys giving back as a volunteer at the Wineglass Marathon and Unified bowling matches; and
