WHEREAS, With a main campus located in Fairport, New York, and three other adoption centers throughout the community, this nonprofit organization provides shelter, care, and adoption for dogs, cats, small animals, birds, reptiles, horses, and other farm animals; and

WHEREAS, In addition, Lollypop Farm offers educational events and camps for children grades second through ninth, as well as youth and teen volunteer programs; and

WHEREAS, Lollypop Farm is also home to the Humane Law Enforcement Department and is SPCA designated to investigate and enforce animal cruelty laws in the State of New York; and

WHEREAS, Every year, Lollypop Farm houses and cares for thousands of animals, from domestic pets to farm animals who are surrendered to them by residents and law enforcement; and thousands of adults and children experience a new way to live alongside animal friends in their community; and

WHEREAS, Over its distinguished 150-year history, Lollypop Farm serving the Greater Rochester area has demonstrated continuous service to the residents and communities which it serves; and

WHEREAS, The success of Lollypop Farm, Humane Society of Greater Rochester is in direct correlation to the efforts of its staff, volunteers, and donors, whose involvement is, and always has been, characterized by an impressive commitment, an unbridled enthusiasm, and an uncompromising standard of excellence in all endeavors on behalf of the organization and the community it serves; and
