WHEREAS, A motivational speaker, Dr. Roy A. Hastick, Sr has convened over 600 business development seminars that bring together the CACCI membership with other entrepreneurs and the wider business community to network and access business resources, to make contacts and explore contracts; and

WHEREAS, As an ardent supporter of Two-Way trade between the United States and the Caribbean region, Dr. Roy A. Hastick, Sr as an elected delegate to the 1995 White House Conference on Small Business, campaigned and was successful in getting Two-Way trade with the Caribbean region into the final recommendations that were submitted to the United States Congress; and

WHEREAS, Through his tireless efforts, advocacy, and visionary leadership, Dr. Roy A. Hastick, Sr has led CACCI to accomplish several challenging initiatives including providing weekly small business clinics, business services for micro enterprises, small business development networking business seminars, workshops, and monthly power breakfast meetings; and
