COMMEMORATING the 75th Anniversary of the Yates
County Chamber of Commerce on June 1, 2023

WHEREAS, Attendant to such concern, and in full accord with its long-standing traditions, this Legislative Body is justly proud to commemorate the 75th Anniversary of the Yates County Chamber of Commerce on Thursday, June 1, 2023, to be celebrated at the Chamber's Annual Awards Dinner; and

WHEREAS, The Yates County Chamber of Commerce enjoys a relationship with the Keuka Wine Trail (KWT) as its administrative team; the Chamber assists in the production of collateral materials, management of the website, and coordination for ticket sales to KWT events; and
