WHEREAS, Peter E. Clark was always ready and willing to lend a helping hand whenever needed and always greeted his friends with a warm smile; and

WHEREAS, Peter E. Clark is survived by his three sisters, Patricia, Susan, and Ida; three brothers, Joseph (Marcia), Chris (Lisa), and Richard (Ildiko); seven nieces, Kellie, Kimberly, Christine, Cynthia, Kara, Angela, and Jacklyn; three nephews, Brian, Roy, and Johnny; his Aunt Beverly and Uncle Peter Albano, and Aunt Elveta Albano, and many great nieces and nephews, as well as numerous friends who will long cherish his memory; and
