WHEREAS, Kent Hall, MD, who has been practicing medicine since the early 1980s, is the Chief Physician Executive (CPE) at Mohawk Valley Health System (MVHS) in Utica, New York; he will officially retire from this esteemed position in January 2024; and

WHEREAS, Throughout his illustrious tenure as Chief Physician Executive, Dr. Kent Hall has been instrumental in the opening of the new Wynn Hospital in Utica, and has guided the medical team at MVHS through the COVID-19 pandemic, and the most recent move into the new downtown Utica facility; and

WHEREAS, Furthermore, he has been a vital component in the high quality of medical care delivered as well as for driving quality and safety initiatives throughout MVHS, working directly with department chairs, directors of contracted medical groups and hospital-based physicians to coordinate patient care and safety efficiently; and

WHEREAS, Most recently, Dr. Kent Hall served as Chief Medical Officer (CMO) at Champlain Valley Physicians Hospital in Plattsburgh, New York, and Alice Hyde Medical Center in Malone, New York, where he worked to improve patient outcomes and delivery through improved clinical quality processes, as well as operational efficiencies within and between hospital based clinical services; and

WHEREAS, Prior to that, Dr. Kent Hall also served as Medical Director of the Emergency Department at Champlain Valley Physicians Hospital; and

WHEREAS, Kent Hall completed his residency in Emergency Medicine at the University of Cincinnati Hospital in Cincinnati, Ohio; he received

his medical degree from Upstate Medical College in Syracuse, New York, and his Bachelor of Science in Biology and Psychology from Union College in Schenectady, New York; and

WHEREAS, For more than four decades, Dr. Kent Hall's tireless efforts and notable achievements have significantly contributed to bettering the quality of life in his community, truly earning him the admiration, affection, and esteem of his colleagues; and
