WHEREAS, Frank Giotto pioneered the FIS Training Manual, a popular addition to the fiber optic curriculum taught at many colleges, universities, and technical schools; and

WHEREAS, A devoted entrepreneur, Frank Giotto is the President and Founder of Giotto Enterprises, which is composed of seven manufacturing companies and proudly employs 450 people in the Mohawk Valley; and

WHEREAS, Giving back to the community, Frank Giotto served on numerous non-profit boards, including Utica College, UCP-United Cerebral Palsy, Utica Symphony, and Hope House; he shares his success with the community and has made major contributions to Utica Tower, Giotto Center (UCP), Utica Zoo, and Utica College; and

WHEREAS, With a tireless and unwavering commitment to Central New York and beyond, Frank Giotto has devoted his entire life to making communities a better place for its citizens to live, work, and play; and

WHEREAS, This extraordinary man has an immensely beautiful life built on compassion, kindness, and respect for others; he is one of the

most significant and enduring civic and political leaders in the County of Oneida, and his insight and strength will forever serve the countless people he has touched; now, therefore, be it
