WHEREAS, The recipient of numerous awards and accolades, Chad Ryals received the Silver Star and three Purple Hearts; and

WHEREAS, After his years of admirable service, Chad Ryals started a National crisis hotline for veterans, thusly earning the esteemed Community Service Award from the Tribute and Honor Foundation; and

WHEREAS, Residents of this great State must never forget the courage with which these men and women served their country, and must recognize that no greater debt is owed than that owed to those who gave their lives for their beloved Nation and to those who continue to be missing in action; and
