WHEREAS, Rich in history on Long Island, Jason's Vineyard pioneered the practice of densely planting grapevines to intensify wine flavors; the six feet between rows and three feet between adjacent vines are measurements used in the renowned Bordeaux winemaking region of France; and

WHEREAS, The success of Jason's Vineyard is in direct correlation to the efforts of its dedicated owners and staff, whose involvement is, and always has been, characterized by an impressive commitment, an unbridled enthusiasm, and an uncompromising standard of excellence in all endeavors on behalf of the businesses and the communities they serve; and
