WHEREAS, The Utica Lions Club was chartered on February 8, 1924, and
adheres to the Lions mission to empower volunteers to serve their
communities, meet humanitarian needs, encourage peace and promote
international understanding; and

WHEREAS, Devoted to helping others, the Utica Lions Club supports
the Central Association for the Blind and Visually Impaired (CABVI),
Freedom Guide Dogs, American Diabetes Association, Resource Center for
Independent Living (RCIL), Lions Hearing Conservation Program, and the
American Red Cross; and

WHEREAS, Founded in 1917 by Melvin Jones, Lions are also recognized worldwide for their service to the blind and visually impaired; this service began when Helen Keller challenged the Lions to become her "knights of the blind in the crusade against darkness" during the Lions' 1925 International Convention; and
