WHEREAS, Today, Heintz Funeral Service continues to operate the Whitesboro Street and Herkimer Road locations under the direction of Terrance K. Heintz, President/Treasurer and Fred A. Heintz IV, Vice President/Secretary; and

WHEREAS, Since its humble beginnings in 1909 as a small funeral home on Varick Street, Heintz Funeral Service has grown and prospered; and

WHEREAS, Proudly operated by a third and fourth generation of the Heintz family, Terry and Fred continue to provide the tradition of personal service and attention to detail established by Fred A. Heintz Sr., "Celebrating the lives of the ones you love. Since 1909."; and
