WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Sara Mitchell has displayed throughout her life; and

WHEREAS, In the performance of her duties, Sara Mitchell has demonstrated her character and her compassion for the welfare of others; she is a tremendous asset to his EMS Unit and a distinguished citizen of the State and Nation; and
