10, 1971 to October 1971; he served with Americal Division 23rd
Infantry, as well as the 11th and 198th Infantry Brigade in Chu Li in
the Central Highlands; and

WHEREAS, After serving in Vietnam, John J. Conners, Jr. was stationed at Fort Carson, Colorado and was honorably discharged February 14, 1972, holding the rank of SP4; and

WHEREAS, On June 15, 1971, John J. Conners, Jr. was wounded in action and received the Purple Heart; and

WHEREAS, For his courageous and dedicated service to his country, John J. Conners, Jr. received the National Defense Medal, Vietnam Defense Medal, Vietnam Campaign Medal with Device, Bronze Star, and the Combat Infantry Badge; and

WHEREAS, With a steadfast and unwavering commitment to his fellow veterans, John J. Conners, Jr. is a life member of VFW Post 2246 and has served on the executive board; he served four terms as Commander, and held the positions of Chaplain, Color Guard, Executive Board, and he currently serves as 1st Vice Commander; and

WHEREAS, Truly dedicated to his community, John J. Conners, Jr. is also a member of Henry P. Smith Post American Legion, both VFW and Legion in Rome, New York, the Rome Veterans Council, the MOPH and DAV; and

WHEREAS, With him throughout have been his wife, Mary Lou, and their three beautiful children, Kelly, Sean and Shannon, all of whom feel privileged to be a part of his life and rejoice in his achievements; and

WHEREAS, Residents of this great State must never forget the courage with which these men and women served their country, and must recognize that no greater debt is owed than that owed to those who risked their lives for their beloved Nation; and
