School in 1950; that same year, he joined Harmon Engine Company No. 3 of

the Croton Fire Department where he was an active member for more than 20 years, and an over 50-year life member of the department; and

WHEREAS, Ronald B. Luposello, Sr. married the love of his life, Emma, in 1959, at the Holy Name of Mary Church in Croton-on-Hudson, and together they raised three children; the couple was married for 64 years, and were the proud grandparents of six grandchildren and two great-grandchildren; and

WHEREAS, Renowned locally by one of his most coveted titles, Owner of Luposello's Garage, Ronald B. Luposello, Sr. worked shoulder to shoulder with first his father, then his brothers, and for the past 40 years with his son, JR, up until almost the day of his passing; and

WHEREAS, This extraordinary man leaves behind a remarkable legacy, and his impact on the local community will resonate for generations to come; he dedicated more than eight decades of his life to keeping community residents on the road through his work at the garage; his work ethic was second to none, and his passion for his business was intertwined with his passion for his family; and
