Legislative Body records the passing of Josephine Spano, noting the
significance of her purposeful life and accomplishments; and

WHEREAS, Josephine Spano of Yonkers, New York, passed away on
Wednesday, December 6, 2023; and

WHEREAS, A native of Yonkers, New York, Josephine was born on
January 6, 1934, and attended Commerce High School where she met and
fell in love with her teenage sweetheart, Leonard Spano; and

WHEREAS, Josephine and Leonard Spano married on July 12, 1952, where
they moved to California where Leonard was stationed as a U.S. Marine
entering the Korean Conflict; and

WHEREAS, The adoration Josephine and Leonard Spano had for each other deepened with every decade and through Leonard's years of public service as a longtime County Legislator, Westchester County Clerk, and business owner and she remained a supportive force; they were happily married for 67 years; and

WHEREAS, Josephine Spano, the matriarch of the Spano family, instilled the gift of unwavering faith in her family and offered the gift of her guidance, support and dedication to her 16 children, which included former New York State Senator Nicholas Spano and former New York State Assemblyman and current Mayor of Yonkers, Michael Spano, 42 grandchildren and 28 great-grandchildren; and
