WHEREAS, Dr. David Podwall completed his internal medicine internship at the Mount Sinai School of Medicine and completed his residency in neurology at The Neurological Institute of Columbia Presbyterian Medical Center; and

WHEREAS, Upon the completion of his residency, Dr. David Podwall completed a neuromuscular fellowship at Columbia and acquired extensive

experience in electromyography (EMG); while at Columbia, he had multiple publications, including two reviews of diabetic neuropathy; and

WHEREAS, Furthermore, he has published in journals, such as:
