WHEREAS, After first donning his robe in 1996, for 28 years, Judge Michael L. Dwyer, a lifelong resident of New Hartford, New York, rendered his decisions for the cases brought before him as fairly as he could; some cases affected him more strongly than others, but he always remained professional in his judgments; and

WHEREAS, With Judge Michael L. Dwyer throughout his career have been his wife, Marty, a former special education teacher in Utica, and their four children, two of whom have become attorneys; they all feel privileged to be a part of his life and rejoice in his achievements; and

WHEREAS, Now retired, Judge Michael L. Dwyer looks forward to spending more time with his grandchildren and traveling with his wife; and

WHEREAS, While serving the Oneida County Court, Judge Michael L. Dwyer served with loyalty, honor, and distinction; in his official acts, he was governed by a keen sense of duty and always showed a unique grasp
