WHEREAS, Prior to her success at the state level, Fayth Goodspeed won the NYSPHSAA Section 2, Division 1 Championship, with a time of 1:05.31 on November 8, 2024, in Clifton Park, New York in front of a capacity crowd and a fan base of family, friends, and teammates; and

WHEREAS, The athletic talent displayed by Fayth Goodspeed is due in great part to the efforts of Coach Amanda Nappi, the team's expert coaching staff, and skilled and inspirational tutors, respected for their ability to develop potential into excellence; and

WHEREAS, Fayth Goodspeed 's overall record is outstanding; she was loyally and enthusiastically supported by her family, teammates, friends and the community at large throughout her journey; and
