long-standing traditions, this Legislative Body is justly proud to

WHEREAS, St. Joseph Lodge No. 117 was founded in 1953 in the basement of Deacon William Grant of Mt. Zion Church in Mt. Vernon, New York; the first Worshipful Master of the Lodge was Herbert Grant, followed by Charles Webb and Willie Gibson; and

WHEREAS, St. Joseph Lodge No. 117 was a member of the Alpha Grand Lodge of New York City and held their meetings at various churches and the Odd Fellow Hall in Mount Vernon; eventually, the members purchased a building at 28 E. 1st Street where they continue to hold their meetings; and

WHEREAS, In 1983, under the leadership of Worshipful Master Willie Gibson, the Lodge was Under Dispensation (UD) to become a member of the Most Worshipful Prince Hall Grand Lodge of the State of New York, and one year later, it received its Charter; the Lodge was renumbered 117 and became a member of the Third Masonic District; and

WHEREAS, This Legislative Body is proudly moved to honor and commend the members of St. Joseph Lodge No. 117, past and present, who have labored so conscientiously to secure and improve the quality of life for the community they serve; now, therefore, be it
