WHEREAS, Since its inception, Go To Girls has provided 177 Bundles of Love, 120 Birthday Bags, and two Kindness Awards: Bundles of Love ensure that Clarence School children have what they need to keep them warm and safe from the elements during a cold Buffalo winter; Birthday Bags provide a family with everything to celebrate their child's big day; and Kindness Awards have awarded \$2,500 to two graduating Clarence seniors who have displayed acts of kindness; and
