Dear Mr. Christian,

As the State Senator of the 35th Senate District which includes most of the City of Yonkers, the Town of Greenburgh and the Town of Mount Pleasant in Westchester County, I write to strongly oppose the rate increase requested by Consolidated Edison. My constituents are already faced with outlandish electric and gas bills because of the previous increases the PSC has granted to the company.

ConEd's request flies in the face of the priorities of the State Senate, Assembly and the Governor to make life for New Yorkers more affordable. I urge you to deny this request.

This past January, the most recent increase was put into effect, creating extreme hardship for many of my constituents. This was the latest increase which the PSC has granted Con Ed on a yearly basis for at least the past 6 years. It is time to change the game. ConEd's delivery rates are too high now; to increase them further increases the burden on the public.

The company's rationale for the rate increase has been the same every year. And every year they are successful. They need more money to replace infrastructure and distribution lines, to build more underground lines, and to enhance customer service. Nowhere in their rationale is how these improvements will lead to lowering the cost of energy. Improvements and maintenance should not be made on the shoulders of their customers.

I have seen bills from my constituents where ConEd's delivery costs are twice as much as their supply costs. This is unfair and should be reviewed. Their request for an 11.4% increase for electricity and a 13.3 % increase in gas places an extra burden on people who are already in sticker shock with their current bills.

I am aware that ConEd has asked for this one year increase with the hope that they will negotiate with the PSC for three year increases at a lower rate. It is a game, and either way, it's the customers who feel the impact.

On behalf of the residents and businesses in my district, I urge the Public Service Commission to listen to the public and to deny ConEd's request to increase its already excessive energy rates.
