WHEREAS, Today, Rotary International has grown into an organization including over 1.2 million members in approximately 29,000 clubs across the 163 countries; each club is made up of professionals and business leaders who are dedicated to humanitarian service, encourage high ethical standards in all vocations, and to help build peace and goodwill throughout the world; and WHEREAS, The Rotary Club of Geneseo, New York was founded on April 2, 2025, and has been a driving force in fostering civic responsibility, promoting humanitarian service, and enhancing the quality of life in the community; and

WHEREAS, Since its inception, members of the Rotary Club of Geneseo have worked tirelessly to support various charitable projects, service initiatives, and community development efforts in Livingston County and beyond, embodying the Rotary motto, "Service Above Self"; and

WHEREAS, The Rotary Club of Geneseo has provided educational scholarships, organized local food drives, assisted in public health initiatives, supported youth programs, and improved public infrastructure in ways that have had a positive and far-reaching impact on local residents; and

WHEREAS, The members of the Rotary Club of Geneseo have exemplified the true spirit of volunteerism and community service, providing a model of dedication and leadership for others to follow; and

WHEREAS, The Rotary Club of Geneseo is an integral part of the global Rotary organization whose efforts in fighting diseases, supporting education, and promoting peace and goodwill throughout the world continue to inspire individuals and groups to engage in acts of kindness and compassion; and
