a successful career with the Village of Philadelphia, where he quickly advanced to the position of Assistant Superintendent; he earned certifications as a lineman and wastewater treatment operator and extended his expertise to assist with the Village of Antwerp's wastewater program, demonstrating his unwavering commitment to the welfare of his community; and

WHEREAS, Ryan Phillip Gleisner was also the proud owner and operator of RG Hauling & Excavation, a business he founded and nurtured, reflecting his entrepreneurial spirit and passion for hard work; and

WHEREAS, Deeply involved in his community, Ryan Phillip Gleisner served as a fire council member of the Philadelphia Volunteer Fire Department, where he was recognized as Fireman of the Year in both 2020 and 2021 for his unwavering dedication and selflessness; and

WHEREAS, A devoted advocate for agriculture, Ryan Phillip Gleisner was a Past President of the Indian River FFA, an active member of the Jefferson County 4-H Club, and the Holstein Association; his love for farming was evident in his continued involvement with FFA and 4-H, where he earned the prestigious American Degree Award and numerous other distinguished honors while mentoring and inspiring future generations of young farmers; and

WHEREAS, Ryan Phillip Gleisner's boundless love and devotion extended to his family, including his parents, Dean and Shelly; his maternal grandmother, Carol Clarke Fikes; his sister and brother-in-law,
