WHEREAS, Before embarking on a distinguished 35-year career in the banking industry, Maurice M. Chalk Jr. was an entrepreneur and proprietor of The Snack Shack on Albany Post Road, a local establishment fondly remembered by many; and

WHEREAS, Maurice M. Chalk Jr. began his illustrious banking career as a teller at The County Trust Company, a community institution that valued his dedication and leadership; he retired as Regional Vice President at the Bank of New York, a testament to his professional excellence and work ethic; and

WHEREAS, Deeply civic-minded, Maurice M. Chalk Jr. gave generously of his time and talents to numerous local, county, and state organizations; his community involvement included serving as a former member of The Peekskill Community Ambulance Corps, Co-Chairman of St. Patrick's Church Parish Council, Chairman of its Finance Committee, and Treasurer of the Verplanck Fire District; and

WHEREAS, Maurice M. Chalk Jr. also served on the Westchester County Youth Board, the Salvation Army Advisory Board, and as Vice President and Board Member of the American Association for the Improvement of Boxing, among other endeavors; and

WHEREAS, A man of strong faith and deep conviction, Maurice M. Chalk Jr. believed in service to others; he was also an avid fan of the New York Yankees and a passionate follower of boxing; and

WHEREAS, Above all, Maurice M. Chalk Jr. was a devoted husband, father, grandfather, brother, and friend; he is survived by his loving wife of 60 years, Angela Avati Chalk; two children, Patrick (Ann Marie) and Michael; his brother, John; sister-in-law, Marie Ray; five cherished grandchildren, Briana, Ryan, Michael, Nicholas, and Justin; and his

nieces and nephews, Melissa, Emily, Allison, and Brian; he was predeceased by his parents, Maurice Sr. and Catherine Chalk; his stepmother, Katherine Chalk; his brothers-in-law, Raymond Ray and John Avati; and his sister-in-law, Jerri Chalk; and
