WHEREAS, The high standards of care and support provided by The Arc Madison Cortland has been cultivated by Perry Courto and his skilled leadership team, and they have been reaccredited from The Council on Quality and Leadership in March 2019 and August 2023; and

WHEREAS, The drive, dedication, and heart of Perry Courto, in tandem with his experienced staff, fostered exceptional care for the people supported by The Arc Madison Cortland; and

WHEREAS, Perry Courto will serve in a new role as senior advisor to facilitate a smooth leadership transition during the next year, and he looks forward to spending more time with family in his retirement; and

WHEREAS, It is the sense of this Legislative Body that when individuals of such noble aims and accomplishments are brought to our attention, they should be celebrated and recognized by all the citizens of the great State of New York; now, therefore, be it
