WHEREAS, Neal Currie, who as been with Albany Community Charter School since its inception, currently serves as the Principal; his keen vision and leadership appropriately serves as a model for the school; and WHEREAS, The Albany Community Charter School teaching staff is dedicated to ensuring that their students receive a high-quality education which prepares them for a lifetime full of opportunity; and WHEREAS, In the 2008-2009 school year, Albany Community Charter School administered the New York State Testing Program for the first time; 100% of the third grade class achieved a score of "Proficient" or "Above Proficient" on the 2009 New York State math assessment; in addition, 97% of the third grade class achieved a score of "Proficient" or "Above Proficient" on the 2009 New York State English Language Arts assessment; and
