unstintingly; and

WHEREAS, As a stay-at-home mom, Deidra Graulich became the consummate volunteer, serving as President of the Cedarhurst-Woodmere ORT and as a soccer coach, Little League coach, Brownie and Cub Scout leader, and PTA volunteer; and

WHEREAS, As her children grew, Deidra Graulich secured a substitute teaching license, was immediately offered a six week full-time job teaching a special education class and spent the next ten years working with special needs students; while doing so, she returned to school to earn a master's degree in reading and special education and an advanced degree in administration; and

WHEREAS, An outstanding teacher, leader, and administrator, Deidra Graulich continued to rise through the ranks serving as a Teacher Leader, Assistant Principal, and ultimately as Principal of Public School 63 in the Ozone Park area of Queens, where she continues to be a strong advocate for students, deeply committed to ensuring they have the opportunity to receive a quality education; and

WHEREAS, With her throughout have been her husband, Karl, and their children, Lance, Dean, and Heather, all of whom are proud to be part of her life and rejoice in her many achievements; and
