Richter courageously persevered and recovered his ability to walk when

and his family received from the New York State Police during his ordeal, Paul A. Richter headed a successful effort to create the Gray Rider State Trooper Monument in tribute to all the generations of men and women of the State Police; the monument was unveiled on September 30, 1993, the 20th anniversary of his injury; and WHEREAS, An inspiration to all victims, families and advocates who have been affected by violent crime, Paul A. Richter has lent support and counseling to hundreds of victims and their families over the years; he has devoted himself to raising money to support medical research to find a cure for spinal cord injury (SCI); and WHEREAS, As Chairman of the Capital District Chapter of the Spinal Cord Society, Paul A. Richter has organized annual fundraising events; he was instrumental in the creation of the Spinal Cord Injury Research Board that has invested millions in neurological research toward a cure for SCI, and serves on its Board of Directors; and WHEREAS, Throughout the entire period of his professional and community service, a period of constructive involvement, Paul A. Richter has stood constant in dignity, good grace and humor, and has earned the respect and admiration of his colleagues, family and friends; rare indeed is the impressive dedication shown by an individual for the benefit of others which he has displayed throughout his life; and WHEREAS, Supporting Paul A. Richter throughout has been the love, devotion and courage of his wife, Marie Claire, and his entire family; and
