WHEREAS, As Chief Operating Officer of Svante, a green technology start-up, Jessica Haller works to solve global environmental issues with a focus on Riverdale; and

WHEREAS, Also, through the Riverdale Jewish Center, she introduced Green Tips, a program widely used by area schools and synagogues which provides practical ways for people to improve the environment and, working with former Vice President Al Gore's Climate Project, she has made numerous presentations to local organizations; and

WHEREAS, Jessica Haller is a LEED (Leadership in Energy and Environmental Design) Accredited Professional and earned a Master of Public Administration degree from Columbia University as well as a Bachelor of Science degree from the University of Pennsylvania; and

WHEREAS, Jessica Haller and her husband Chad, an eye doctor, are the proud parents of a daughter, Leila, and a son, Avery, and have resided in Riverdale since 2000; and

WHEREAS, It is the sense of this Legislative Body that when individuals of such noble aims and accomplishments are brought to our attention, they should be celebrated and recognized by all the citizens of the great State of New York; now, therefore, be it
