United Synagogue of Conservative Judaism; she is the new president of the Hadassah Brooklyn Region, and has been honored by numerous Jewish organizations, including being named Woman of the Year by Israel Bonds, Na-Amat, and Masores Bais Yaakov of Brooklyn; and

WHEREAS, In 1991 during the Persian Gulf War, Gail Hammerman volunteered in Israel and served with the Israeli Army; an honorary member of the Shomrim Society and the Honor Legion of the New York City Police Department, she is also an advocate for SHARE; and WHEREAS, Professionally, Gail Hammerman served as Special Assistant to
