WHEREAS, Sandy Wolf also served for several years as the Director of both Adult Treatment Services and Community Support Services; as a volunteer, she is matched with two women through Compeer and serves as the board member of NAMI-FAMILYA; and

WHEREAS, With Sandy Wolf throughout have been her three children, Tracey Drayer, Jamie Wolf-Rivera and David Wolf, and seven grandchildren, Joel, Jessica, Max, Marc, Michael, Jacob and Leah, all of whom feel privileged to be a part of her life and rejoice in her achievements; and
