WHEREAS, Grapevine Farms has been growing steadily ever since; Tim and Tracy continually look for ways to make changes for the better and strive to keep things fresh, new and exciting and, happily, their first three years in business far exceeded their projected business plan; and WHEREAS, In 2006, Grapevine Farms took a major step forward, doubling its physical plant size and making possible the addition of a commercial kitchen and the Farmhouse Bistro which offers delicious lunches and is the perfect complement to the friendly country shopping experience that Grapevine Farms had already become; and WHEREAS, The spring of 2007 saw the addition of The Greenhouse at Grapevine Farms; in 2008, Grapevine Farms added beer and wine to its dining room menu and its latest addition, the Grapevine Farms Wine Cellar, opened in September 2009, featuring only New York State wines and offering free daily samplings of featured state wineries; and WHEREAS, Grapevine Farms now employs 30 full and part-time staff who are warm, caring and friendly individuals who help make Grapevine Farms a destination where both locals and tourists can eat, shop, sample New York State wine, visit the coffee bar, or just sit and chat; and WHEREAS, In just a few short years Tim and Tracy Purcell and Grapevine Farms have become valued, contributing members of the Schoharie County community; the Purcells work hard to generate pride in their community, hosting fundraising events, and generously giving to the community in many ways, enhancing the quality of life in Schoharie County; and WHEREAS, It is the sense of this Legislative Body to acknowledge such outstanding enterprises as Grapevine Farms and individuals such as its owners Tim and Tracy Purcell whose professional lives, personal endeav-
