WHEREAS, Returning to New York, Dr. Grigoletto completed her post-graduate training and residency in Pediatrics at St. Vincent's Medical Center, Staten Island, after which, in 1988, she joined the pediatric practice of Dr. Charles DeGennarro and Dr. Diana Pintus-Emma; today, Dr. Grigoletto is a founding partner and current President of Island Heights Pediatrics, with offices in Dyker Heights, Staten Island, and Old Bridge, New Jersey; and

WHEREAS, Dr. Grigoletto is Board Certified by the American Board of Pediatrics and is a Fellow of the American Academy of Pediatrics; she has been an Attending Physician at Richmond University Medical Center, formerly St. Vincent's Medical Center, and Staten Island University Hospital for more than 20 years and, active in her profession, she is a member of the Richmond County Medical Society and the Brooklyn Pediatric Society; and
