WHEREAS, Rabbi Kupchik, in addition, studied at the Jewish Theological Seminary of America in New York City, where he earned a Master of Arts degree in Talmud and Rabbinic Literature and was awarded the Saul Lieberman Graduate Fellowship in Talmudic Studies; and

WHEREAS, Rabbi Claudio J. Kupchik is married to Ann-Rebecca Laschever and they are the proud parents of two children, Jacob and Simon; and

WHEREAS, Throughout his rabbinical career, Rabbi Kupchik has initiated many innovative programs including Rabbi's Rovers, a group which combined prayer and singing with nature walks; Project Dialogue, an interfaith and interracial group promoting friendship and cooperation; and Shabbateeny, a Shabbat experience geared to nursery school age children; and

WHEREAS, Rabbi Kupchik also instituted Spark-Heartaction, a program which included teenagers and adults in Jewish learning at the synagogue in combination with visits to residents of the nearby New York State Veterans Nursing Home, where he also generously and ably served as Chaplain; and

WHEREAS, Rabbi Kupchik has, in addition, always been very involved in interfaith dialogue and community affairs having served as both Vice President and President of the Peekskill Area Pastors' Association (PAPA) and as Co-chair of the Task Force on Diversity established by the Town of Cortlandt Manor, New York; and

WHEREAS, The true architects of society and community are those whose faith and unremitting commitment serve to sustain and enhance the spiritual and cultural values of life; Rabbi Claudio J. Kupchik has distinguished himself in his profession and by his sincere dedication and substantial contribution to the congregations and communities he has served; and
