WHEREAS, A man of singular distinction, Robert A. Sherwood has continually demonstrated extreme competence, extraordinary intelligence and diligent leadership in his unwavering service to his community; and WHEREAS, Robert A. Sherwood has been Chief Executive Officer and President of Kinderhook Bank since 1995; this community bank was established in June of 1853 and officially opened for business in October 1853; and WHEREAS, Robert A. Sherwood began his employment with the bank in 1976 as a management trainee and first served as a teller; he was soon promoted to assistant-cashier in 1977 and then rose to the position of Executive Vice-President in 1983; he served in this capacity until 1995 when he was promoted to President; and

WHEREAS, During his tenure, Kinderhook Bank has grown from the Main Banking Office in Kinderhook and a single branch office in Valatie, New York, to five banking centers in Columbia and Rensselaer Counties; and WHEREAS, The bank is currently the only local bank headquartered in

Columbia County and as a community bank it is vigilant in protecting assets and assuring the short and long-term stability of the bank; and WHEREAS, Despite his busy professional life, Robert A. Sherwood has been called upon to contribute his time and talents to countless civic and charitable endeavors and has always given of himself unstintingly; and

WHEREAS, Currently, Robert A. Sherwood serves as a director on the boards of Columbia Economic Development Corporation and the Center for Disability Services of Albany, New York, the Alice & Murray Giddings Foundation as well as the Kinderhook Education Foundation; he is also a member of the Valatie Santa Claus Club and the Fifty Group of Columbia County; and

WHEREAS, Robert A. Sherwood has formerly served as Treasurer of St.

Paul's Episcopal Church and as a board member for the Columbia County

Planning Board, Town of Kinderhook Assessment Review Board, Residential

Opportunities, Inc., Shaker Museum, and the Hudson Development Corporation; he is also the past President and member of the Northern Columbia County Rotary Club; and

WHEREAS, A resident of Kinderhook, New York, Robert A. Sherwood holds a Graduate Banking Certificate from the School of Community Banking at the University of Texas at Austin; he attended C.W. Post College in Greenvale, New York, and Nassau Community College in Garden City, New

York; and

WHEREAS, Throughout the entire period of his community service, a period of constructive involvement, Robert A. Sherwood has stood constant in dignity, good grace and humor; and WHEREAS, With him throughout has been his wife, Suzanne, who feels privileged to be a part of his life and rejoices in his achievements; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Robert A. Sherwood has displayed throughout his life; and

WHEREAS, It is the sense of this Legislative Body that those who enhance the well-being and vitality of their community and have shown a long and sustained commitment to excellence certainly have earned the recognition and applause of all the citizens of this great Empire State; now, therefore, be it
