speech for the New York State Office of Disabilities; and WHEREAS, She then returned to the Department of Education as a speech teacher in District 22 and afterward became an Educational Evaluator in District 18, after which she served as a Special Education Evaluation and Placement Officer (SEEPO) for District 18 and then for District 22; and

WHEREAS, In her current position as the Chairperson of the Committee on Special Education at Flatlands Avenue, covering Districts 17, 18 and 22, Arlene Rosenstock understands that the parents who come to her office are seeking help and guidance and, along with her staff, she and her team make every effort possible to see that all children receive the appropriate services to succeed; and

WHEREAS, With Arlene Rosenstock throughout have been her husband Alan; their children and their spouses, Binyamin and Brianne, Ely and Ruthie, and Aliza and David; and their grandchildren Mark, Eden, Bailey, Noah and Yoni, all of whom are proud to be part of her life and rejoice in her many achievements; and
