WHEREAS, Attendant to such concern, and in full accord with its longstanding traditions this Legislative Body is justly proud to honor Robert A. Zaloom, M.D., upon the occasion of his designation by Lutheran HealthCare as the recipient of a Sister Elisabeth Fedde Medal of Service at its 127th Annual Dinner Dance, to be held at the Grand Hyatt Hotel at Grand Central Terminal on Saturday, May 8, 2010; and WHEREAS, This year, at its Annual Dinner Dance, Lutheran HealthCare celebrates its 127-year legacy of providing quality health care to the communities of Brooklyn and honors those who have made noteworthy contributions to Lutheran and the patients it serves; and WHEREAS, Bay Ridge native and Director of the May Ellen and Gerald Ritter Cardiology Center, Robert A. Zaloom, M.D., has significantly contributed to Lutheran HealthCare's success and truly merits the Sister Elisabeth Fedde Medal of Service, named after Lutheran HealthCare's 1883 founder and bestowed upon individuals who continue Sister Fedde's legacy of service and commitment; and

WHEREAS, Dr. Zaloom has dedicated his career to providing cardiac care in Brooklyn for more than twenty years; born and raised in Bay Ridge, he attended St. Patrick's Elementary School and Xaverian High School, where he began his career in medicine, working as a volunteer nurse's aide at Coney Island Hospital in a unique high school program, revolutionary for its time; and

WHEREAS, He went on to attend New York University, continuing to work

in the hospital on weekends to help pay for his education, and after earning a bachelor's degree in chemistry and mathematics, he attended graduate school and earned a master's degree in biochemistry; he then completed four years of medical school, a three-year internal medicine residency at Lutheran, followed by a fourth year as Chief Medical Resident, and a fellowship in cardiology at SUNY Downstate; and WHEREAS, After graduation, Dr. Zaloom returned to Lutheran as an attending physician in cardiology and joined the practice of Nagi Bustros, M.D., and Antoine Fernaine, M.D., which recently expanded to include Thao Ngo, M.D. and George Fernaine, M.D., and was renamed "Bay Ridge Hearts"; and

WHEREAS, Dr. Zaloom is, in addition, a full attending physician at Lenox Hill Hospital and an Assistant Professor of Medicine at Mount Sinai Hospital; and

WHEREAS, Dr. Zaloom regards the crowning achievement of his career to be the opening of the May Ellen and Gerald Ritter Cardiology Center at Lutheran Medical Center in 2005; the center recently joined forces with Mount Sinai and has received both FDNY STEMI Center and New York State designations to perform emergency and elective angioplasty (PCI), making it Brooklyn's newest full service cardiac center; and WHEREAS, Dr. Zaloom and his wife Joan, a former Lutheran CCU nurse, are the proud and loving parents of four children, all born at Lutheran

WHEREAS, He is a member of the Bay Ridge Medical Society and regularly lectures in the community on cardiac nutrition, which is of special interest to him; and
